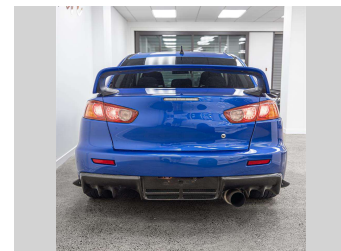

The total amount of repayments has been calculated by multiplying 260 weekly repayments (based on a 60 month term) by the weekly repayment amount of \$137.96 which equals \$47,566.17.
